#### Scope

This report outlines the activities of the Te Arawa Lakes Trust in the Rotorua/Te Arawa Lakes Programme.

#### **Summary**

The key focus of the third quarter of the 2020/21 year has been leading the Tarawera Collective Impact project and continuing to add value to the Te Arawa Lakes Programme on behalf of our Te Arawa beneficiaries.

The Te Arawa Lakes Trust team has also been working towards a response to Te Hononga about engagement on the National Policy Statement for Freshwater Management implementation by the Bay of Plenty Regional Council.

#### Te Arawa/Rotorua Lakes Programme

#### Te Tūāpapa is embedded into the Lakes Strategy programme

- 1. The engagement plan for the roll out of Te Tūāpapa and He Mahere Taiao is in implementation phase as we are working with RLC Parks and Reserves to finalise a date for our next workshop.
- 2. Te Tūāpapa and He Mahere Taiao has formed the basis of our input to the BOPRC Long term plan submission.

#### Te Arawa Lakes Trust - Statutory responsibilities

#### **Lakes structures and Consents**

- 3. The Te Arawa Lakes Trust has been working closely with Rotorua Lakes Council and its contractors on the Lakefront Development, particularly about the monitoring and management of koura.
- 4. A submission on the Alum dosing consent has been made by TALT supporting the recommendations of the Cultural Impact Assessments undertaken by hapū and lwi for the Puarenga and Utuhina Streams.

#### **Policy and Planning matters**

- 5. TALT continue to engage with BOPRC on Plan change 14 Onsite Effluent Treatment systems
- 6. TALT is working with RLC on a CIA for the Rotorua Stormwater Catchment comprehensive consent.

- 7. TALT is working on the Implementation of Te Papa Ahurewa an Environment Unit to support hapū and Iwi engage in consents, policy and planning matters including the NPSFM.
- 8. TALT, via the NICF and Freshwater Iwi Leaders Group is involved in co-design of the RMA reforms.

#### Te Arawa Lakes Trust - Te Arawatanga

#### Te Arawa Climate Change Working Group

- 9. Te Urunga o Kea met with the Climate Commission and made a submission to on the Advice Report which will form the basis of the advice to Government.
- 10. The key points were to ensure the advice includes recommendations to support Tiriti based decision making processes in the implementation of the advice and the development of the policy that will implement that advice is co-developed and delivered with the Te Tiriti partner.
- 11. The Working group is currently working on an advice paper to Government highlighting the key points across the submissions made by hapū and lwi.
- 12. Te Urunga o Kea are working with BOPRC to pilot an adaptation approach based on Te Ao Māori for future planning decisions.

#### Mauri Tu Mauri Ora - Jobs for Nature

- 13. Te Arawa Lakes Trust secured \$2.5m to restore wetlands supporting the employment of up to 30 people over the next 2 years. To date TALT has employed 18 individuals in various roles with 13 of these working directly in wetlands and waterways from Maketu through to our Lakes environment.
- 14. A MSD/Doc funded training programme to develop capacity and capability in this area has begun with 9 weeks remaining.

#### Te Arawa Lakes Trust - Engagement

#### Catfish Volunteer Programme

15. The Catfish Killas continue to operate on Lakes Rotoiti and Rotorua with 29 schools registered and around 100 volunteers participating in the programme.

#### **Biosecurity**


- 16. TALT and BOPRC trained 17 individuals from across Rotorua as Biosecurity officers and this team have been rostered at Boat Ramps across the Lakes since October 2020, through until April 2021. Their role was to ensure Check, Clean Dry processes are followed and to educate the public about the threats to our Lakes and the new self-certification process implemented under the Pest Management Plan.
- 17. To date a total of 1191 boat ramp inspections were undertaken by TALT with only 14 failing, this is a compliance rate of 98.8%. A total of 1068 inspections have been undertaken by TALT staff since the new rule came in, with 246 certifying and 822 not certifying. This is a compliance rate of 23% overall with a small trend of increasing compliance rates.





Gross actual costs have been unadjusted to inflation, proximity to mains or contribution to the capital replacement costs of the main WWTP.

#### Requested Change

Increase Deed Funding allocation in 2020-2021 Annual Work Programme for weed harvesting on Lake Rotoehu from \$59,000 (\$27,000 Crown Funding) to \$200,000 (\$100,000 Crown Funding).

The increase in funding to this intervention for this financial year is covered by underspends in the phosphorous locking interventions on Lake Rotoehu and Lake Rotorua so there is no overall increase in expenditure.

#### Reason for Change

After a hiatus of 6 years, we have had enough weed growth on Lake Rotoehu to run the weed harvester. The harvester has been working over the last few weeks to remove all of the available hornwort which is then loaded onto trucks and transported to a composting operation near Taupō.

Algae and high lake levels have hindered weed growth and prevented harvesting in recent years but changed conditions this year have meant prolific growth. Because of the conditions in recent years this activity was conservatively budgeted in the Annual Work Programme.

Rather than stop removing the weed to align to the allocated budget, staff have kept the harvester going to gather all of the available weed before it dies back. This has exceeded the budget in the 2020-21 Work Programme approved by Strategy Group but that exceedance is covered by underspends in phosphorous locking on this lake and on Lake Rotorua so there is no effect on the overall budget.

The community are extremely supportive of this initiative, stopping by the operators bring food and drinks!

#### Proposed Resolution

Approve additional \$141,000 spend on Lake Rotoehu weed harvesting project for the 2020-2021 financial year, noting the additional spend on this intervention is covered by underspends on phosphorous locking within the Te Arawa Lakes Programme.

### Lake Rotoehu Update

Compliance audit of all benchmarks and agreements completed at Lake Rotoehu with full compliance:

- Pastoral area reduced from 1790ha to 1175 ha
- Native bush increased from 1152 ha to 1390 ha
- Plantation trees increased from 737ha to 1123 ha
- Phosphorous loss reduced from 4,577 kg to 2,474kg
- Nitrogen loss reduced from 59,015kg to 44,327kg




